**Annexure-1 (for minimum qualification)**

The interested party/bidder is required to have the following minimum qualification:

1. Should be Income Tax assessee having PAN No. and regularly filed IT returns for the AY 2009-10 to 2012-13. The copies of returns are required.
2. The minimum turnover/ receipts from hiring business should be Rs. 15,00,000/- for the financial year 2012-13. The copy of balance sheet is required.
3. The vendor is not black listed by any central/state govt. department.
4. The vendor should have presently engaged by atleast two govt. organisations.
5. The vendor should have its permanent parking stand within 10 kms. from the radius of the Khan Market, New Delhi.
6. The vendor should have running current account / OD account with Commercial bank.
